# GIFT AID DECLARATION

## Boost your donation by 25p of Gift Aid for every £1 you donate

Gift Aid is reclaimed by Bromsgrove from the tax you pay for the current tax year. Your address is needed to identify you as a current taxpayer. For every £1 donated by a UK tax payer, 25p in reclaimed tax is added by the Government. For example, a donation of £800 using Gift Aid is worth £1,000 to Bromsgrove once tax has been reclaimed.

In order for gifts to be eligible for Gift Aid, the donor must be a UK taxpayer who will have paid an amount of income tax and/or capital gains tax at least equal to the tax that the Foundation will reclaim on the gift in the tax year in which it is made.

If you pay higher rate tax, you can claim the difference between the higher rate of tax (40% or 45%) and the basic rate of tax on the total 'gross' value of your donation in your tax return. For example, if you donate £800, the total value of your donation to Bromsgrove is £1,000 – so you can claim £200 if you pay tax at 40%, and £250 if you pay tax at 45%. The end cost of your gift to Bromsgrove is then £600 if you pay tax at 40%, and £550 if you pay tax at 45%.

You can see what a difference signing and dating the Gift Aid Declaration box below can make:
